Mark your course content with a copyright statement

Put people on notice that your content is protected by copyright. You can also make it clear that they are not allowed to copy or adapt your content without permission.

Contractual protection can fill gaps left by copyright law and give you additional rights.

Understand common copyright myths

Understand them, and they won't trip you up. There are many myths out there. For example, this is a myth: "I've only copied 10% / 20% of their work, so I should be OK." There are many more.
